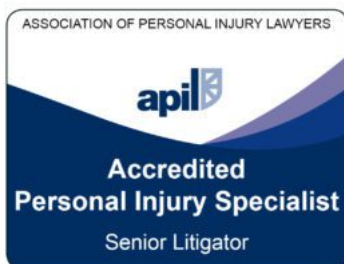

Notable Personal Injury cases

Public Liability Claim
