Lasting Powers of Attorney

John represented two clients in a challenge to a Lasting Power of Attorney made when the client believed the donor lacked capacity. This case involved a forensic analysis of the timeline of events, contrasting capacity assessments and contested deputyship applications. It was important in this case to gather as much information as possible from public bodies to understand the complete picture about capacity at various junctures and advise concisely to the clients on the options and the likelihood of success.

John acted for the Deputy of a farmer with several hundred cattle and several farms spread out across the county. This involved a deep understanding of the agricultural work that is involved in managing a farm in partnership with the local farm agent and investigating allegations of impropriety by a former attorney including applications for a Statutory Will. This required getting involved in the challenge he was making to his Deprivation of Liberty authorisation and
