Surgical Error

Delay in Diagnosis & Treatment

Advised at inquest and obtained compensation for the Estate of the Deceased and the mother of the deceased in separate actions when the hospital failed to treat the deceased in a timely manner leading to the deceased's death – £67,500 total settlement.
